

To Whom It May Concern,

I am seeking an exemption from _____'s requirement related to the COVID-19 virus. I have both religious and philosophical objections that make it impossible for me to comply with your COVID-19 policies related to the mRNA vaccines.

Most states have laws that offer explicit protections of its citizens' religious objections to certain state public health policies. Some states even offer laws that protect its citizen's philosophical rights in addition to religious ones. I write to assert my religious and philosophical rights, which are in part protected by Title VII of the Civil Rights Act of 1964 and possibly even protected by this specific state's laws.

The FDA has released the mRNA vaccine for Emergency Use Authorization which means that it has not yet been fully approved as it is still in a clinical trial phase. Also, the word *vaccine* is a misnomer for this emergency treatment. It can be more accurately argued to be a gene therapy or medical intervention. I have a reasonable doubt that the near-term and long-term safety data regarding this medical procedure is complete and accurate.

In addition to the above, requiring an experimental medical procedure as a condition of employment or freedom is a direct violation of Article 1 of the Nuremberg Code. Violations of this nature have been generally recognized by most civilized nations to be both unethical and immoral.

Furthermore, the very fact that the Nuremberg Code can be referenced to defend a position to not take part in an experimental medical procedure to retain employment lends credence to the idea that our civilization is at a very dangerous crossroads where a spiritual evil has infiltrated our government and is now colluding with our schools, hospitals, and various other institutions in order to coerce tens of millions of people into submitting to an experimental gene intervention that at best can be described as dubious and at worst malevolent.

God has gifted every human being with a soul, a body to house that soul, and a mind to protect that vessel. He has bestowed upon each recipient the discretion to nurture those gifts. Summarily removing a person's right to decide, no matter how insignificant, on how best to care for their mind, body, or soul detracts from the substance of those gifts and blessings.

Genuine consent should be absent of coercion lest it cheapens the value of self-determination. Compulsory injection of any foreign substance regardless of its composition into another human being's body without the option of legitimate consent violates this tenet and would be immoral. And if the intended substance should contain harmful additives, chemicals or toxins and/or were derived either directly or indirectly from harvested aborted fetal tissue then that is possibly criminal if not evil and could be interpreted as corruption of the flesh and thus degradation of the vessel.

There is at present a spiritual war being waged between those who believe themselves to have dominion over the populous and those who would choose for themselves the opportunity to

preserve what God has naturally given them. I firmly and sincerely believe that we are all in very real danger from the mRNA vaccine's medium to long-term effects and I choose to exercise my God-given right to guard my body and soul from this perceived threat.

In conclusion, for all of the foregoing reasons, I hereby declare myself a conscientious objector to the mRNA COVID vaccine and provide my dissent in writing. I will not consent to receive this medical procedure until such time as I am fully convinced that it has been properly and thoroughly vetted.
